## YEAR IN REVIEW

## by the Village of Orland Park Board of Trustees

Orland Park had a busy and successful 2018! Our community continues to be the destination of choice for people to live, work and enjoy life. New businesses are opening and existing businesses are reinvesting in Orland Park.

Orland Square Mall is undergoing major reinvestment, with the announcement of the new AMC theater and Von Maur. A very special 'thank you' goes out to our community partners; School Districts 135 & 230, Orland Fire Protection District, and the Orland Park Public Library, for working collaboratively with the village to close the deal to bring Von Maur to the Orland Square Mall.

Von Maur, to be located in the former Carson's location, is expected to be open for the 2019 holiday shopping season.

The Village of Orland Park's Downtown Triangle District Project is moving forward into the final phase of development. The final phase will lean upon the previous successful phases that resulted in new commuters, residents, employment and visitors to the area.

In 2018, the village issued a Request for Qualifications/ Proposals for development of the remaining nine acres of land.

Six development firms submitted proposals and after a thorough review process the village board selected Structured Development, LLC to complete the project.

The village is pleased to have selected Structured Development as the developer of this important project. Our vision for the parcel combined with the expertise of the developer will surely result in a phenomenal addition to the Orland Park community.

Re-investment is occurring throughout all of the major business corridors. The 159th street Auto Corridor continues to dominate the automobile sector, with the opening of the new Infinite and Porsche dealerships. The former military base at Lagrange Road and 156th Street has become home to three new restaurants, with one remaining outlot available for development. This site is now a successful project that will contribute to the future economic base of the village and all of the other taxing bodies in Orland Park.

The village board worked closely with staff to reduce Orland Park's operating budget by approximately 1.7 million dollars. We are committed to maintaining fiscal accountability and will continue implementing efficiencies to make the most of our hard-earned tax dollars.

We have begun to live broadcast meetings on Facebook Live to make sure the meeting information is more accessible to everyone. The audio recordings are also available on the village website at orlandpark.org.

Looking forward, technology implementations to drive efficiency will be put in place and we will continue to build a healthy and flourishing community for residents and businesses.

## CERTIFICATE OF ACHIEVEMENT FOR **EXCELLENCE IN FINANCIAL REPORTING**

The Village of Orland Park once again received the Certificate for Excellence in Financial Reporting for its fiscal year 2017 Comprehensive Annual Financial Report (CAFR). This award is granted in recognition of transparency and full disclosure that goes beyond the minimum requirements of generally accepted accounting principles. The Village has received this award for 31 consecutive years.

## DISTINGUISHED BUDGET PRESENTATION AWARD

Since fiscal year 2006, the Finance Department has been awarded the GFOA Distinguished Budget Presentation Award. To qualify for this award, the village's budget document is judged to be outstanding as a financial policy document, operations guide and communications device.

## 2018 STARGUARD ELITE AWARD

The Village of Orland Park received the 2018 StarGuard award in recognition of the Centennial Park Aquatic Center's (CPAC) efforts as above the industry standard, reflecting a proactive approach to aquatic risk prevention. CPAC also earned a five-star safety rating, the highest rating possible, following an unannounced risk management audit by a national non-profit water safety organization.

## PAFR AWARD

The Village of Orland Park was a recipient of the GFOA's PAFR award. The Popular Annual Financial Reporting Awards Program (PAFR Program) encourages and assists state and local governments to extract information from their comprehensive annual financial report to produce high quality popular annual financial reports specifically designed to be readily accessible and easily understandable to the general public.

# FISCAL STRENGTH

The village continues to adhere to its policy of maintaining fiscal strength by spending within its means, doing more with less and being accountable to residents for every dollar spent. Operating and capital budgets for Fiscal Year 2019 are balanced without the implementation of any significant new revenue sources. As a home rule community, the village has the ability to enact a variety of taxes that would bolster our overall revenues. To date, the village board has chosen to forego these additional revenue opportunities, with the exception of the .75% home rule sales tax that has been in place, at the same percentage, since 2001 and a video gaming tax which was enacted in late 2018. In addition, for the 8th year in a row, the village has kept its overall property tax levy

flat, meaning that property owners, in total, are paying the same amount to the village in 2019 as they did in 2012.

The Village of Orland Park continues to receive excellent bond ratings; an AA+ from Standard and Poor's and an Aa1 rating from Moody's. These ratings reflect the village's strong economy, affluent tax base and healthy financial profile. The village's debt load is moderate, with general obligation bond debt of \$61.8 million as of December 31, 2018. This amount equates to 2.64% of the village's overall value (equalized assessed valuation), well below the Board approved policy level of 8.625%. Since 2009, the village has saved approximately \$6.4 million in future

interest costs by refunding portions of its outstanding general obligation debt. The refunding process is much like a homeowner going through a refinancing process in order to decrease the interest rate paid on their mortgage.

The village continues to maintain fund balances in its operating and capital funds according to board approved fund balance policies, another practice that ensures a continued strong bond rating.

Required reserves are calculated and set aside as part of the budget process, ensuring that expenditures remain within available funding.





# **BUDGET PROCESS**

IN DECEMBER OF EACH YEAR, THE VILLAGE **BOARD FORMALLY** APPROVES BALANCED **OPERATING AND CAPITAL BUDGETS FOR** THE FOLLOWING YEAR. The village utilizes the target based budget method for operating funds; therefore, the budget process begins with the calculation of available sources. Fixed costs are applied against these available sources and the net amount available is allocated to the village's operating departments to fund variable operating costs. Available sources include fund balance remaining after setting aside Board authorized reserve amounts, as well as revenue projected for

the new fiscal year. The village's budget policy is to estimate revenues conservatively and to maintain a spending level less than or equal to current year resources. The issuance of short or long term debt will only occur if needed to fund long-term capital projects and will not be utilized to fund the village's operating budget.

## **POLICE GET SOCIAL**



## THE ORLAND PARK POLICE DEPARTMENT IS NOW USING SOCIAL MEDIA TO FIGHT CRIME WITH FACEBOOK, TWITTER AND INSTAGRAM ACCOUNTS.







The Orland Park Police Department uses social media as an investigative tool when seeking evidence or information about missing persons, fugitives or knowledge about a particular crime. The public is notified with time-sensitive notifications, such as major traffic incidents, weather emergencies, or police action in a specific area that poses a potential threat to the community.

Residents can count on regular features, such as "Wanted Wednesday." The weekly post asks the public to help identify a person of interest wanted in a crime or to help locate a person with an outstanding warrant. Wanted Wednesday posts have helped capture several suspects over 2018 and reached thousands with their social media reach and with the help of national news media that share the feature on their programs and websites.

## POLICE DEPARTMENT EARNS TIER 2 STATUS



## The Orland Park Police Department is again among an elite group of law enforcement agencies in the State of Illinois.

Orland Park joins other police departments that have received the coveted Tier 2 Accreditation Status through the Illinois Law Enforcement Accreditation Program administered by the Illinois Association of Chiefs of Police. Departments are able to submit for accreditation every four years. Orland Park first earned a tier 1 rating and now earned the higher tier 2 rating during the last two reviews. Historically, Orland Park was the fifteenth agency to achieve tier 2 status. An independent team representing the chiefs' association spent two days with the Orland Park police reviewing and examining all

aspects of the department policies, procedures, management, operations and support services. During the two day on-site assessment the assessing chiefs from other departments used nearly 180 separate ILEAP standards to determine if Orland Park met the program's highest level of accreditation standards. The assessors assigned to Orland Park reviewed more than 1000 Orland Park Police Department documents to establish proof of compliance. Hazel Crest Police Chief Mitchell Davis, vice-president of the Illinois Chiefs of Police, attended the February 18 village board meeting to present the

honor. Davis lauded the Orland Park Police Department's policies and procedures, congratulating Chief McCarthy, Deputy Chief Joe Mitchell, the department's prior accreditation manager, and Lieutenant Eric Rossi, the current accreditation manager. "For those who don't know what this means, this is a big deal," Davis said. "It's not a requirement to go through this process. It shows that the Orland Park Police Department operates at a very high professional level. It speaks volumes." Chief Davis presented the honor to Mayor Keith Pekau and Trustee Pat Gira, chair of the village's Public Safety Committee.

# BUILDING COMMUNITY

The Village of Orland Park remains a highly desired destination of choice for businesses to call home. As a Class A retail and restaurant market, Orland Park welcomed both new development and a fresh new look to existing retail spaces with plentiful redevelopment to the area in 2018.







## TEXAS DE BRAZII

Texas De Brazil is converting the former LensCrafter's retail space within the Orland Square Mall into a 6,578 square foot restaurant. The LensCrafter store has relocated to an adjacent space. The Texas De Brazil improvements include both the interior space and exterior facades of the restaurant, and fall entirely within the existing building footprint of the mall, with the exception of adjacent foundation planting beds. The remodel is in line with the style and branding associated with the Texas De Brazil Restaurants.

#### **SERITAGE**

Seritage Growth Properties proposes to redevelop the upper floor of the Sears Department Store in order to construct a new 10 screen movie theater, and a new retail concourse with a mix of retail and restaurant users. The existing Sears Auto Store will also be demolished. Related site improvements include revised vehicular circulation, parking lot landscape islands, a pedestrian sidewalk network, landscaping, repair of existing hardscape, and storm water detention to meet current development requirements.

## **VON MAUR**

Davenport, lowa-based Von Maur will soon find a home for its seventh location in the former 127,594 square foot Carson's space at Orland Square Mall. Proposed changes include a complete interior remodel and a full restoration/replacement of the building facades. The remodeled building will reflect the style and branding associated with Von Maur stores. The location has an anticipated opening in late 2019.



## **PORSCHE**

Porsche finished construction on a new dealership at 8760 West 159th Street, to replace their existing dealership further east at 8100 West 159th Street. The existing dealership will remain as an auto sales use but will likely be re-branded. The new facility will include a new 18,010 square foot building, 206 parking spaces, a detention pond, and two small out lots for future development, all on a 7.6 acre site, currently zoned BIZ General Business District, and located just east of Georgio's Banquet Facilities in Orland Hills.

The existing site prior to the Porsche redevelopment was primarily vacant. There was a bank building on the property however only the parking lot was being leased.

## **INFINITI**

In 2018, Infiniti constructed a new 22,000 square foot facility at 8751 159th Street in Orland Park. In 2018, two long vacant/underutilized parcels saw redevelopment along the 159th Street Corridor. The new construction at Porsche and Infiniti speak to the strength of the 159th Street Auto Row as existing property owners and new developers continue to invest money into the properties to help expand the corridor. In addition, Porsche project constructed a new dealership, allows the expansion of existing dealerships and creates additional parcels that can be utilized for further development of the corridor.



## ANDY'S FROZEN CUSTARD

The former Wendy's Restaurant at 14555 LaGrange Road is being developed as an Andy's Frozen Custard. The 2,131 square foot building is under construction and will have a drive thru. This project is another example of re-investment into the LaGrange Road Corridor, with new construction replacing a formerly vacant restaurant. Andy's Frozen Custard anticipates an opening in early 2019.



## LFI COMPLETION (MILLERS, PDQ, CHUY'S)

Location Finders International (LFI) worked closely with representative from the United States Army to develop a six-lot commercial planned development on the location that formerly housed the United States Army's Area Maintenance and Support Facility.

The property received development approval in the summer of 2017 and was annexed into the village in the beginning of 2018. Since that time, three restaurant out lots have been completed and received occupancy; Miller's Ale House (15630 LaGrange Road), Chuys Tex-Mex (15610 LaGrange Road), and PDQ (15646 LaGrange Road). One lot remains available for development and is being actively marketed.

This redevelopment along LaGrange Road is the culmination of many years of hard work and is an example of a successful redevelopment project.

# DOWNTOWN TRIANGLE



IN 2018, THE VILLAGE **EMBARKED** ON THE FINAL PHASE OF DEVELOPMENT **FOR THE DOWNTOWN** TRIANGLE.

The village released a RFQ in the spring that received six private development proposals. The village then invited two finalists to submit a proposal for the remaining nine acres of village-owned property within the Triangle. In November, the Village Board unanimously voted to select Structured Development as the private developer.

Structured Development, a Chicago-based real estate development company, has vast experience in the real estate market, including the award-winning NEWCITY mixed-use development in Lincoln Park. This project, completed in 2015, includes

over 390,000 square feet of mixed use space and community events. Structured Development strives to unlock and enhance the value of real estate and to improve the urban and suburban fabric through conscious and innovative real estate development.

The village is currently negotiating a Master Development Agreement with Structured Development. Final plans are being prepared with an anticipated public hearing process in the fall of 2019. The Village Board and Structured Development hosted a public visioning meeting in February to solicit public feedback on the vision.

## **ROUNDABOUT**

2018 saw the completion of the roundabout at 147th Street and Ravinia Avenue. The roundabout is functioning as expected with increased traffic flow, less delays and no accidents reported.

While we understand it may take time to get accustomed to the new method of travel at the intersection, we believe the benefits are already shown at this location.

## Benefits of a Modern Roundabout...

## IMPROVED TRAFFIC FLOW

- 30-50% increase in traffic capacity.
- Shorter delays now and into the future even with an increase in traffic.
- There have been zero (0) crashes or traffic incidents reported at the 147th Street and Ravinia Avenue intersection since the installation of the new roundabout.

## **ENVIRONMENT**

 Less idling for cars, less gas being burned into the atmosphere, better fuel economy.

#### **COMMUNITY BENEFITS**

- Provide landscaping and green space opportunities.
- Crosswalks included for pedestrians and bicyclists.

## SAFETY / TRAFFIC CALMING

- All vehicles travel in same direction.
- Vehicles never cross paths, which reduces number of serious crashes.
- Slower vehicle speeds give drivers more decision making time.
- Roundabouts eliminate head-on and high-speed right-angle collisions.
- No traffic lights to install and maintain.
- There are 75% fewer conflict points in roundabouts than in traditional intersections (no head on or right angle accidents). 8 Conflict Points on a roundabout versus 32 Conflict Points on a traditional intersection.





## LAGRANGE ROAD

The Village of Orland Park was recognized by the American Public Works Association for the LaGrange Road Corridor enhancements and honored with the 2019 Project of the Year Award, The American Council of Engineering Companies 2019 Engineering Excellence Award as well as the 2019 Merit Award.

## 151ST STREET

151st Street will be reconstructed from LaGrange Road to West Avenue, which will include widening the roadway, eliminating drainage ditches, and installing a traffic roundabout at West Avenue.

## **167TH STREET PEDESTRIAN PATH**

A multi-use path will be installed along the south side of 167th Street from Will-Cook Road to 104th Avenue. Project will include a bridge at the SW corner of Will-Cook Road and 167th Street, a pedestrian railroad crossing and retaining wall. Currently this project is in Phase I Design Engineering.



# STRATEGIC PLANNING



The village is undertaking a new multi-year strategic plan. Strategic plans are one of the central tools for progressive leadership and management of an organization. The village has entered into an intergovernmental agreement with the Center for Governmental Studies at Northern Illinois University (NIU) to facilitate our strategic planning process.

Leading up to the workshop was a series of focus groups with key stakeholders. The purpose of the focus groups was to gain insights on community views, share perspectives/ideas and explore goals/priorities for the workshop. That data will then be aggregated and brought to the board's workshop.

Strategic assessments and long-term planning are hallmarks of progressive organizations and the value of strategic planning continues to be recognized by the professional public and private sector organizations. Strategic planning is a process and not a onetime event and is the preferred approach to guiding the Village's future. Strategic planning helps leaders become proactive, rather than reactive, and lessens the need to manage crisis by crisis.

The strategic planning framework for the Village of Orland Park was designed to be a comprehensive approach. It was structured to include external input and data from a variety of perspectives including stakeholders' focus groups and two-days of village board and senior management staff workshops.

This process of collecting data from both the internal and external environment is a key piece in developing a strategic plan. In addition to being a scan of your environment, the village's approach provided stakeholders with significant opportunities for positive civic engagement and input.

During the workshops, all participants were able to provide input and exchange ideas. While there were differences of opinion at times, different views are not only valuable but are to be expected on particular issues or policies in a governing environment – this is democracy in action!

Throughout the planning process, a picture of the village's present and future was in strong evidence, as was the desire to positively and proactively to plan for the village's future.

Above model generally represents the steps that are taken for this type of initiative.

# **STRATEGIC** PRIORITY AREAS

Several key strategic priority areas surfaced during the sessions and were observable in many of the goal areas.





# WHERE **HISTORY** IS PRESENT

MUSEUM'S MISSION - THE ORLAND PARK HISTORY MUSEUM AIMS TO INSPIRE A SENSE OF COMMUNITY BY OFFERING ENGAGING AND EDUCATIONAL EXHIBITS AND PROGRAMS AND BY COLLECTING AND PRESERVING ARTIFACTS THAT DOCUMENT THE HISTORY OF THE ORLAND AREA AND ITS RELATIONSHIP TO LOCAL, STATE, AND NATIONAL HISTORY.

#### **COLLECTIONS AND RESEARCH**

- The museum strives to connect the public with Orland Park's history. One way staff and volunteers succeed in doing so is through the preservation of over 10,000 artifacts housed at the museum. Staff and volunteers have accessioned and cataloged hundreds of artifacts and answered dozens of research inquiries.
- New projects at the museum:
  - Scanning the photographic collection, preparing the collection to eventually be digitized on the museum's website
  - Completing a finding aid for the archaeological collection and starting a finding aid for the Humphrey and textile collections
  - Rehousing textile collection and taking photographs of each item to place on the outside of the archival box with its appropriate accession
  - Organizing and rehousing Humphrey family playbills and music sheets, dating as early as the late 1800s
  - Completing the acquisition and housing process for Andrew Corporation newsletters, consisting





of over 450 newsletters, about 75 historic books, magazines, and manuals from local families of Orland Park, hundreds of postcards belonging to the Loebe family, and hundreds of advertisements and postcards from the 1893 World's Fair in Chicago.

- Unique items added to the collection in 2018:
  - 19th-century baby carriage
  - 1900 fire hose cart
  - 19th-century wood table and chair belonging to the Grosskopf family of Orland Park
  - Early 1900s wood rocking chair belonging to the Humphrey family

#### **EXHIBITS**

 Two new exhibits were introduced at the museum - Houses of Worship, detailing the history of the

- churches and mosque in Orland Park, and Orland in War, covering the different Orland veterans who served during the Mexican-American War through today.
- The Orland Fire Protection District donated a circa 1900 fire hose cart to the museum, which is now permanently on display along with old fire department photographs.
- In October, the exhibit space was painted a new beige color, giving the space a more warm and welcoming feel
- In October, the museum received new exhibit walls from Lab Exhibits, Inc., providing more wall space for hanging shelves, posters, photographs, and displaying documents and artifacts. They have provided the space with a more "modern" appearance. The walls will allow for more exhibitions to be installed or more artifacts to be displayed.

#### PROGRAMS AND EVENTS

- The museum saw a great number of attendees at the different programs offered in 2018.
- There were 15 programs, including some with great presenters covering topics like Al Capone, the Fort Dearborn Massacre, history of Orland's old Methodist Church (present-day Twin Towers Chapel), and magic.
- Program content varied, covering local, state, and national history, which provided program goers with a great deal of variety and fun.
- The museum participated in the Taste of Orland, promoting the museum and its memberships, programs, and sold some postcards, for its third year. For the first time, the museum had a table at Market in the Park and the National Night Out against Crime event with the Orland Park Police Department.



## ORLAND PARK NATURE CENTER

## **OUTDOOR FACILITY** LOCATED AT 13951 LAGRANGE ROAD.

Work is well underway on the Orland Park Nature Center! Site improvements will focus on the over three acre site just north of the Metra line that was acquired in 2012 with funds from the Village's Open Lands Program. Improvements include a flexible outdoor gathering space with a multipurpose amphitheater to accommodate a variety of uses and group sizes, a new permeable paver parking lot and drive aisle that traverses the site, and a looped trail system that winds around the site and includes seating areas and examples of native plant and animal community restoration. North of the drive aisle, a boardwalk will extend over the existing detention area to a bird watching station and wetland overlook. The 24 acre wetland area that borders the Nature Center was donated by the Gianakas family to the Village of Orland Park. This will serve not only as a focal point for the Nature Center, but also as a great opportunity for the preservation and restoration of a large area known for its bird populations.

# **VILLAGE DONATES** PLAYGROUND EQUIPMENT TO COMMUNITIES IN NEED



Playground equipment that was decommissioned last year has found new life more than 7,500 miles away on a playground in Pakistan. The equipment once resided at Veterans Park and was replaced when the park was renovated and updated in 2018.

In late November 2018, a team of volunteers gathered on a school playground in Karachi, Pakistan and reassembled the equipment for immediate use.

"As a father I recognize the importance of play in the development of children's physical and emotional well-being," said Trustee Dan Calandriello, chair of the village's Recreation and Parks Committee. "We are thrilled to be a part of making the playground equipment available to children in need."

The Kids Around the World organization partners with other organizations to establish playgrounds in poverty-stricken communities worldwide.

Parks and Grounds Department Director Gary Couch was happy to partner with the Kids Around the World organization and help facilitate the donation saying "We could not think of a better way to make use of our still usable playground equipment than to give it a home where it is new once again."

Since 2012, the village has partnered with the organization annually as it replaces and updates area playgrounds. Equipment from Hertz, Sunny Pine and Eagle Ridge I parks were removed and donated to community playgrounds around the world.

Couch added, "Not only are we providing for others, we are also saving taxpayer dollars by doing so."

In addition to making good use of old equipment, the partnership with Kids Around the World cuts down on costs overall as the organization disassembles and removes the playground structures from the park which would otherwise cost the village thousands of dollars to remove itself

"It really is a win-win situation for all involved," said Calandriello. "We hope to continue this partnership that helps us repurpose old playground items while bringing the joy of play to those in need."







## SPECIAL EVENTS



#### **Outdoor Summer Events**

The 2018 outdoor events were well received by patrons once again.

Three highly anticipated concerts were held in 2018.

- Centennial Park West with an estimated attendance of 1.000 at the event:
  - September 2: Trippin Billies, Tickle Me Emo, and Breakfast Club
- ♣ Concerts in the Park held at Crescent Park entertaining approximately 250-300 patrons at each.
  - June 24: Brass Tracks, provided a great jazz performance followed by the Southwest Community Concert Band.
  - August 19: HiFi Superstar entertained patrons with Rock/Pop music.

The Veterans Liberty Run/Walk was held in Centennial Park on July 3 and turned out to be the largest to date with over 417 participants.

Taste of Orland Park 2018 showcased a selection of 21 of Orland Park's finest restaurants, with an estimated attendance of over 45,000 people throughout the weekend event. Highlights included headliners Rod Tuffcurls and the Bench Press, 7th Heaven, and American English along with Kids' Day, the Car Show, OP's Got Talent, and the Veterans Concert. The event drew large crowds all three days and the weather was hot. Staff received positive feedback on entertainment and restaurant selections from many attendees.

The new Harvest Hoedown event held Saturday, September 22, was well received by participants. Patrons enjoyed dinner from City Barbeque, music by the Suburban Cowboys, craft beer tastings and a variety of games; the bull riding was a big hit! The University of Chicago was a presenting sponsor along with City Barbeque, and the décor was provided by Shop the Barn.

The 30th Annual Turkey Trot had 922 participants; 900 participated in 2017. This event continues to grow each year.

#### SPECIAL RECREATION

The 50th Anniversary of Special Olympics Day of Inclusion was held on July 21, 2018 at Soldier Field with 23 Orland Park participants attending. Terrence Regan, our long time Special Olympics participant was also in attendance at the inaugural Special Olympic International Games held 50 years ago.

Fourteen Special Olympic athletes participated in the State Floor Hockey Tournament on November 17, 2018 at Northeastern Illinois University in Chicago. The team took home a Bronze Medal.

48 Village of Orland Park Special Olympic athletes competed in the Illinois Special Olympic Summer Games at Illinois State University Friday, June 15 through Sunday, June 17, 2018.

## ORLAND PARK HEALTH AND FITNESS CENTER

In 2018, the village budgeted over \$500,000 to make several improvements to the facility: Pool repairs including painting and replacing heaters; men's, women's, and family locker rooms and saunas were repaired; 28 pieces of selectorized & weight equipment were purchased; and portions of the Fitness Center were painted. The parking lot was seal coated and restriped. New drive and sidewalks were constructed and opened. Parks Department initiated new, low maintenance landscaping in parking islands and on east side of the building.



### **CPAC**

Memorial Day Weekend started the 2018 season with the highest attendance in the last eight years at 6,312 patrons (an increase of 4,450 over 2017). Annual attendance continued high throughout the season at a total of 83,678 (an increase of 8,483 or 12% over 2017). The attendance was higher in 2018 than 2017 though fewer days were open in 2018 (open 87 days, closed 14 days because of rain or cold).

Memorial Day weekend also generated a sale of 183 passes (an increase of 76 passes over 2017). The full season generated a total of 1,901 passes sold. The season generated revenues totaling over \$944,120 (an increase of \$55,380 over 2017).

CPAC has received 5-Star scores on 29 of the last 30 audits over the last 10 years earning CPAC an overall 5-Star score in each of those 10 years. 5-Star is the highest score possible in StarGuard Elite audits.



### PATRON PARTICIPATION

- ♣ In 2018 over 83,600 patrons visited the aquatic center, an increase of 12% over 2017.
- ♣ Over 1,800 pool memberships were purchased in 2018, similar to 2017.
- ♣ Recreation program enrollment reached over 16,500 patrons in 2018, (a 6% increase from 2017).

### THEATRE

The Orland Park Theatre Troupe opened the 2018 season with its spring production, "Pirates of Penzance," held at the Carl Sandburg Performing Arts Center was well received by the audiences during the three performances with a total of 664 tickets sold. "Touchtone For Murder" was held in July selling 140 tickets total for both performances. The final production of the year, "The Christmas Express," sold 221 tickets, and was enjoyed by patrons during three performances. All three theatre productions brought in a total of \$19,543 in revenue.



# ARTS COMMISSION CULTURAL SERIES

The Arts Commission presented three events in 2018, which were all well received by patrons and included: Southwest Community Band Concert, Joni Bishop Art Exhibit and Concert, and a poetry slam.

### **SPONSORSHIPS**

2018 Sponsorship revenue totaled \$156,351, an increase of 45% over 2017 Sponsorships of \$108.625.


The Village of Orland Park provides and maintains 64 village parks, over 30 miles of trails, 139 athletic fields/courts and approximately 300 acres of open space acquired through the Open Lands of Orland Park program. Over 600 acres of park space meets the needs of residents and visitors of all ages and a variety of interests.

# IN 2018, THE PARKS AND GROUNDS DEPARTMENT COMPLETED THE FOLLOWING TASKS:

- Replaced two vertical turbine filtration pumps at Centennial Park Aquatic Center with updated flooded suction pumps. Improvement allows for faster cleaning of filtration baskets and provides redundancy in the event of mechanical issues allowing uninterrupted operation.
- ♣ All exterior slides repaired and gel coated to prolong life. This process allowed the changes of colors to provide a fresh and inviting new appearance to Centennial Park Aquatic Center.
- ♣ Installation of five (5) Variable Frequency Drives. VFD's prolong

- life of pumps and turbines at Centennial Park Aquatic Center. This equipment also reduces the amount of electricity used to power the operations of the aquatic center.
- ♣ Began second iteration of pool drain replacements for the zero depth vessel. An improvement to drain covers keeping patron safety at the forefront of operations.
- ♣ Installed replacement sump pump system and rails into overflow vault for the lazy river and activity pool vessels. Increased capacity allows for more efficient removal of ground water.

- ♣ Installation of mister systems (three units) at Centennial Park Aquatic Center for patrons.
- Centennial Park Aquatic Center.
- ♣ Balanced chemistry of over 750,000 gallons of water at the Centennial Park Aquatic Center.
- ♣ Installation of additional thousand (1000) pound CO2 expansion tank and acid booster system to provide expanded control of water chemistry systems at Centennial Park Aquatic Center.



- Landscaping redesigned and updated at Orland Park Health and Fitness Center.
- Preventative and restorative maintenance of athletic fields allowing safe play.

On December 3, 2018, the Village Board formally approved balanced operating and capital budgets for Fiscal Year 2019. The total Fiscal Year 2019 budget reflects approximately \$144.2 million in revenues and \$149.3 million in expenditures. The variance between total revenues and total expenditures, approximately \$5.1 million, consists of carryover budget savings, or operating surplus, from Fiscal Year 2018 and prior.

The Village's budget policy is to estimate revenues conservatively and to maintain a spending level less than or equal to current year resources. Operating expenditures are compiled utilizing the "target based" budget method; a method that begins with the calculation of available sources. Fixed costs are applied against these available sources and the net amount available is allocated to the Village's operating departments to fund variable operating costs.


Early in 2018, the Board of Trustees reviewed an updated version of the Village's long-term financial forecast. Although the FY2018 budget reflected a significant reduction in non-personnel operating expenditures, in order to maintain Board approved fund balance levels in the Village's general operating fund well into the future, significant additional operating expenditure reductions needed to occur. Based upon the need for these reductions, the Village Board authorized early retirement incentive programs that would reduce the Village's workforce through attrition, thereby significantly reducing operating expenditures for a number of years. The FY2019 budget includes the elimination of eighteen (18) full-time positions beginning on or after June 30, 2019, as well as further reductions in non-personnel operating expenditures of approximately \$941,000, without significantly affecting services to our residents.

### PROPERTY TAX LEVY

The 2018 property tax levy included in the FY2019 budget amounts to \$13,425,519, an amount that has not changed in eight (8) tax years. This means that in total, taxpayers are paying the same amount to the Village in 2019 as they did in 2012. This revenue source will be used to fund \$3,126,200 in debt service payments due on the Village's outstanding general obligation debt, \$6,397,765 in contributions to employee pension plans, \$3,054,470 to fund a portion of public safety salaries, and \$847,084 to fund a portion of recreation and parks operations.


### FINANCE AWARDS



## PROPERTY TAXES


Property taxes are levied on an annual basis to fund various costs incurred by the village, including public safety (partial funding), employee pensions (IMRF, FICA, Police Pension), recreation services and amenities (partial funding) and debt service (partial funding). Less than seven percent of a resident's annual property tax bill goes to the village to fund these costs.



### PROPERTY TAX LEVY

The village's property tax levy has remained flat for eight (8) straight years. This means that, in total, taxpayers will pay the same amount to the village in 2019 as they did in 2012.


The 2018 levy reflects debt service levy abatements in the total amount of \$4,044,286. As opposed to levying property taxes for the payment of principal and interest on a portion of its outstanding debt, the village utilizes other revenue sources to make these debt service payments.



# **SALES TAX**


Sales tax (1%) and home rule sales tax (.75%) collections are projected to remain relatively flat based on the current economic outlook and trends in actual sales tax revenue collections during FY2017 and FY2018. Sales tax is utilized to fund general operations of the VIllage; home rule sales tax funds capital, debt service payments and, when approved, the Village's property tax rebate program.

### **DEBT**

Orland Park's outstanding GO bonded debt as of December 31, 2018 amounted to \$61,805,000, equating to a GO to EAV ratio of 2.64 percent. This ratio is comparable to a homeowner having a mortgage balance of approximately \$10,560 on a home with a market value of \$400,000.
