**SHED - RULES & REGULATIONS**

THIS HANDOUT IS ONLY A GUIDE, ALL APPLICABLE VILLAGE CODE AND LAND DEVELOPMENT CODE ORDINANCES APPLY. A SIGNATURE BELOW INDICATES YOUR UNDERSTANDING OF EACH VILLAGE OF ORLAND PARK REQUIREMENT LISTED BELOW. THIS FORM MUST BE COMPLETED BEFORE YOUR PERMIT CAN BE SUBMITTED AND ISSUED. **Applies to:**

- All Shed Installations

**Permit Fees:** (Found in Village Code, Title 5, Chapter 2)

- \$150

**You are responsible to adhere to the following conditions:**

- A legible copy of your Plat of Survey is required. Indicate on the survey exactly where the shed will be located. Include distance from the side and rear lots lines. Indicate distance from house also, if applicable.
- Limited to one (1) shed per lot, not exceeding 200 square feet.
- Maximum height of shed is 15 feet.
- Sheds are allowed in the rear yard only, behind the rear building line.
- Sheds must be a minimum of 5 feet from side and rear lot lines.
- Sheds cannot be placed closer than 10 feet to house.
- Sheds are not allowed on easements and cannot obstruct storm water flow.
- Material under shed (base) \_\_\_\_\_ (A base or pre-pour inspection is required)

- Final inspection of shed is required before materials can be stored inside.
- Maximum lot coverage is limited for each Zoning District. See Village Land Development Code.
- YOU ARE RESPONSIBLE FOR ANY COVENANTS YOUR SUBDIVISION MAY HAVE REGARDING SHEDS.
- **Sheds are to be used for storage of household and yard equipment equipment only.**

**Required Inspections:**

1. Inspection requests can be faxed to (708) 403-6215, submitted online using the Online Inspection Request Form, emailed to [inspectionrequest@orlandpark.org](mailto:inspectionrequest@orlandpark.org) or submitted in person to the Development Services Department.
2. Inspection requests cannot be taken over the phone and cannot be taken for same day inspections.
3. Inspection requests must be submitted by 4pm to schedule for the next business day.
4. Inspection requests submitted on a Friday after 4PM or on Saturday or Sunday will be scheduled the following Tuesday.

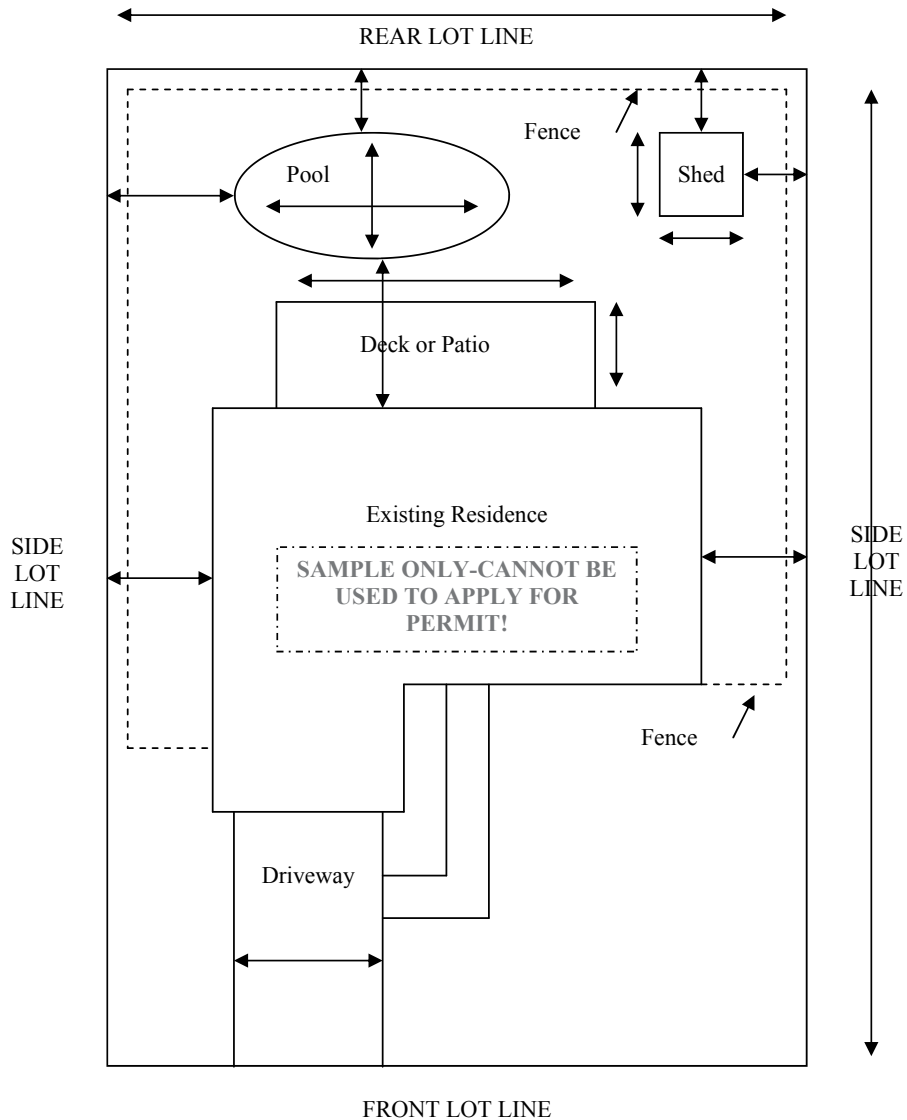



